Lyxor / Bridgewater Core Global Macro Fund - Class A USD (the "Fund")

ISIN: IE00BKS2WX42 - A sub-fund of the Irish collective asset-management vehicle named Lyxor Newcits IRL III ICAV (the "ICAV") domiciled in Ireland. Managed by Lyxor Asset Management S.A.S. ("LAM")

Objectives and investment policy

The Fund's investment objective is to seek capital appreciation over the medium to long term.

The Fund is actively managed and seeks to achieve this objective by investing (on a long and short basis) in equity, bond, interest rate, credit (through direct investments on debt securities or bonds, or indirect investments in derivatives such as CDS), currency, commodity markets and the volatility thereof in both developed and emerging markets. The Fund also uses FDI extensively to both implement direct market exposures and for hedging purposes.

More specifically, the Fund will seek to generate returns while minimizing volatility caused by shifts in economic conditions through diversification across different asset classes and financial instruments that feature different sensitivities to economic conditions.

Investment decisions will be made by implementing the Investment Manager's proprietary investment strategy (the "Trading Strategy"), which is a disciplined, fundamental and systematic investment strategy grounded on the belief that the return of asset classes is driven primarily by changing macroeconomic factors and their influence on markets.

Considering market conditions, the Investment Manager anticipates that the long-term volatility (measured as annualized standard deviation of monthly returns) of the Fund might be of approximately 9%.

The share currency is the US Dollar (USD).

- **Invested financial instruments:** International equities, debt instruments, units or shares of collective investment schemes, financial derivatives instruments ("FDI") such as but not limited to futures and forward contracts, swaps and total return swaps, options and exchange traded commodities
- **Dividend policy:** all the Fund's amounts available for distribution (if any) shall not be distributed to Shareholders, but reinvested.
- **Net Asset Value:** is daily calculated on each business day
- **Redemptions:** Requests for redemption of Shares on a given Valuation Day must be given by indicating the number of Shares and shall be centralised by the Registrar and Transfer Agent before 1:00 pm Irish Time on the first Business Day immediately preceding the relevant Valuation Day

Risk and reward profile



The risk-return category shown above is based on the maximum level of risk that the Fund manager may take while adhering to the Fund's strategy, as well as on its performance, where applicable. This risk estimate may therefore not represent a reliable indicator of future risk, and may be subject to change over time. The lowest category does not mean risk free investment.

The Fund has been classified within category 6. Category 6 indicates that it is possible to suffer a severe loss of capital under normal market conditions ; the value of your investment may change substantially and have quite large daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus): not applicable.

- **Counterparty risk:** The Fund is exposed to the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- **Risk of Financial derivative Instruments:** The Fund invests in financial derivative instruments. These financial derivative instruments can induce different types of risks such as (but not limited to), leverage risk, high volatility risk, valuation risk or liquidity risk. If this risk occurs, the net asset value of the Fund may decrease significantly.
- **Liquidity risk:** In certain circumstances, for example in case of low trading volume on financial markets, any buy or sale trade on financial instruments held by the Fund or having an impact on its value may lead to important variations of their valuations. In such circumstances, the net asset value of the Fund could be negatively affected.
- **Credit risk:** The Fund is subject to the risk that any issuer could become insolvent or to otherwise event having an impact on the credit quality of this issuer. The consequence of this risk or event may result in a decrease of the net asset value of the Fund.

Charges for this Fund

The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
